The business of investing

After all the policy making and drafting, the Trust implemented our investment policies and operations in 2021. The brokerage account was opened and the investment's rebalancing strategy with it's diversified portfolio launched. Our newly appointed trustees: Neo Tshabalala, Carol Coetzee, Bea Croudace and Peter Keyworth are all to be commended for their dedication and commitment to achieving industry standard governance policies and operational routines. It is not only getting the job done, but getting the job done right. We bid a sad farewell to Bea when she relocated to Cape Town and resigned as a trustee. Bea's contribution to the Foundation Trust has been invaluable. Not only did she bring a wealth of institutional knowledge about trusts, but she understood the business of running a school having been the Bursar at Kearsney College for most of her career.

Alignment

The other key focus for the Epworth Foundation Trust's 2021 activities came under the banner 'Alignment'. This was implemented with both the School and, through developing a closer working relationship with the Epworthians, the School's alumni. At the request of the Trustees, our quarterly meetings include representation from the Epworth School Board and the Epworth School Trust.

Systems and innovations

While there was certainty in some arenas there was uncertainty in others:



KwaZulu-Natal was flung into turmoil with the civil unrest and looting in July 2021. The Epworth campus was unscathed but the impact of these events underscored how vulnerable we are to events beyond our control. We need to recognise the changeable environment in which we function and be deliberate about our ability to adapt with commensurate agility.

The Epworth Foundation Trust has implemented a customer relationship management system to maintain a record of all our contacts, whether these are Epworthians or friends of Epworth or generous donors committed to educating girls. Having a database is invaluable to any organisation but especially invaluable to a donor organisation.

The next milestone was the finalisation of the electronic Paygate for processing donations to the Epworth Foundation Trust. This platform is compatible with all major eCommerce platforms and enables the Foundation to accept credit cards, debit cards, EFTs, Zapper and more. An associated notable development was accessing the GlobalGiving platform so the Epworth Foundation Trust could receive regular foreign currency donations. GlobalGiving is the largest global crowdfunding community. It connects vetted nonprofits, donors, and companies in nearly every country around the world. Through GlobalGiving, Epworthians and other philanthropic donors residing abroad can donate to Epworth and receive their tax certificates.

Audit outcomes and disbursements

Of interest to donors, especially corporate donors, is the Trust's audit outcome. The Epworth Foundation Trust is proud to advise that our annual financial statements for 2021 reflect a clean audit.

The Foundation Trust extended a R250 000 tranche of funding to Epworth as a contribution towards real and meaningful transformation and diversification. Epworth's choice to address and improve how people engage within our community, both on and around campus, is important to us and worthy of such a financial contribution.

Educating girls

Lastly, but certainly not least, is the contribution made by Andrew Pfaff, the Trust's co-opted technical advisor. Andrew has patiently educated the trustees on the requirements of diversified portfolios, the requirement to reduce volatility by managing risk and the effect of unnecessary draw downs on the compounding returns.

After a hugely successful series of lectures with the accountancy classes of the High School during 2021, Andrew has re-committed himself to a follow-up residency in June 2022. The Epworthians of tomorrow gain a thorough grounding in compounding returns and the basic tenets of financial investment, just enough to pique their appetites for learning more and being unafraid to ask the important questions.

Towards greater harmony

From time to time, requests are made of the Foundation for financial support beyond bursary provision. Through the recent dark days of the COVID-19 pandemic, Epworth also needed to respond urgently and with open mind and heart to the #blacklivesmatter movement calling for global social change.

The School Executive, in consultation with governance, committed over the ensuring two years (longer, if required) to improve Epworth's understanding of the root causes of social tension and how best to navigate a way forward.

This financial investment made by the Foundation Trust during 2020/21, offered a range of aids to our Epworth pupils and the broader Epworth community, including professional workshops, certain financial hardship assistance upon request, and more.

Through this process, Epworth's culture, values system, characteristic thought processes and behaviours were revisited and deeply analysed. Whilst not a process that has a definitive starting or ending point, Epworth's commitment to change and to improve was seen as a non-negotiable priority.

Instead of denying or pushing back, Epworth chose to INVEST in ways of moving towards deeper understanding and greater mutual respect.

This is work-in-progress but we believe investment is key to help us acquire the skills to build a better and more diverse community for tomorrow.



Our school has been a pioneer in social transformation and a consistent deliverer of world-class education in South Africa for over a century. The Epworth Foundation consistently and diligently seeks funding to provide bursaries for talented and deserving high school pupils who could not otherwise afford an Epworth education.




Neo Shabalala, founder and **CEO: Governance Management** Consulting

Andrew Pfaff, founder of Coherent Commodities, with 30 years' award-winning experience in local & international financial markets







Capital raised + expenses



Amanda Capucci Polzin (Class of 2009)



Instead I was encouraged to be the best I could be. I would love to see other disadvantaged girls from rural areas or townships receive the education I did and watch them excel. Linda, a law graduate, has spent 33 years in the financial services sector in Europe. Her work has included extensive fraud case investigations with Scotland Yard and the Danish financial crime squad. Currently she spearheads financial anti-crime strategies with the Danish security police on money laundering and anti-terrorist financial programmes.

Strategic partnerships

Epworth was selectively and distinctively chosen eight years ago to be a partner high school of highest standing with the Allan Gray Orbis Foundation. The Allan Gray Orbis Foundation programme supports pupils who are in financial need, have an entrepreneurial mindset and the potential to excel academically. The Epworth Foundation is proud to assist with this almost decade-long programme by additionally funding these scholarship recipients.



Through the Epworth Foundation, a distinctive scholarship opportunity emerged in 2018 with the international company MAHLE, a leading supplier to the global automotive industry. Epworth matriculant Katja Vonkeman was awarded the opportunity to study

engineering at the company's German base and she is now close to graduating as part of the growing cohort of stellar young global women engineers. In a recent email to our Foundation, Katja wrote excitedly: 'I am just loving my degree! With every new module, I become even more convinced that this is the perfect course for me. I wish I could study forever and am eternally grateful to the Epworth Foundation for opening this door of opportunity for me.'
